








Natural Gas Market By Days DRP (TL/'000 Sm3)




December 2024 Natural Gas Market By Days Max / Min DRP (TL/'000 Sm³)





Natural Gas Market Number of Orders




December 2024 Natural Gas Market Number of Orders and Trades






Natural Gas Market Trade Volume (mio.Sm³)



Natural Gas Market By Days Trade Volume (mio.Sm³)




Natural Gas Market Annual Accumulated Trade Volume for 2024 (mio.Sm³)






Natural Gas Market Annual Accumulated Transaction Volume for 2024 (Million TL)










Natural Gas Market Positive Imbalance Volume (mio.Sm3)

December 2024 Period Negative and Positive Imbalance Volume (mio.Sm³)








Natural Gas Market Gas Entry Volume (mio.Sm3)
