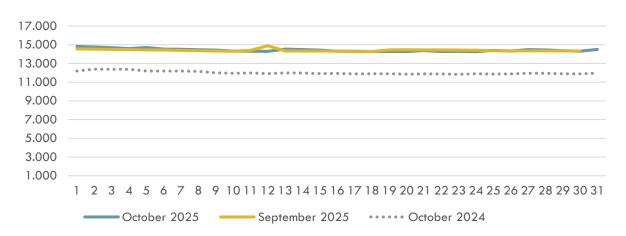

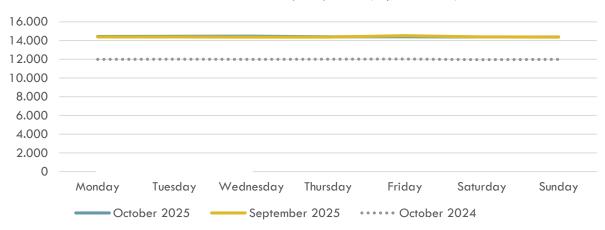

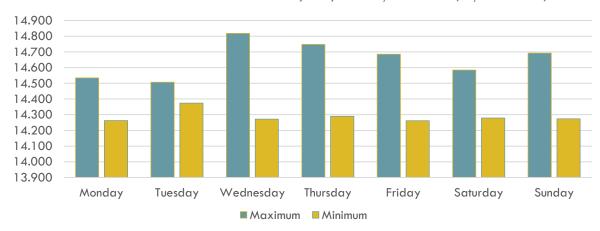




## Natural Gas Market By Days DRP (TL/'000 Sm<sup>3</sup>)



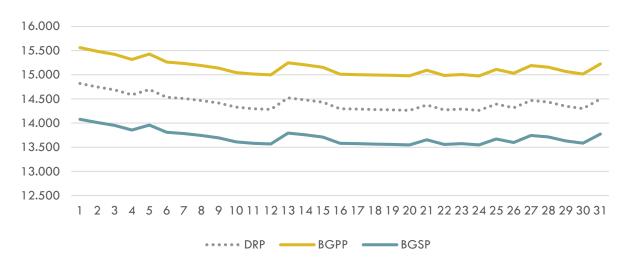
# October 2025 Natural Gas Market By Days Max / Min DRP (TL/'000 Sm³)

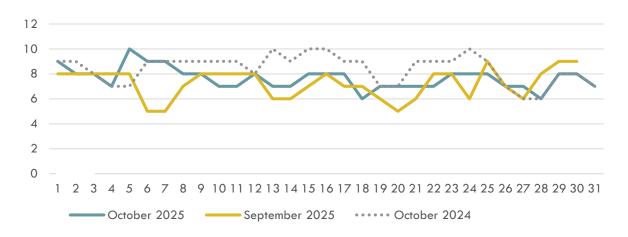

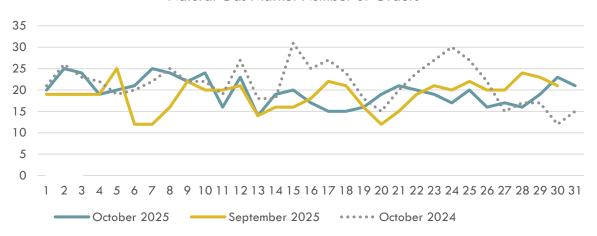

#### Natural Gas Market Number of Orders



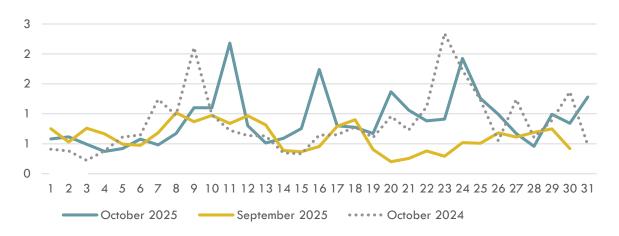
## October 2025 Natural Gas Market Number of Orders and Trades



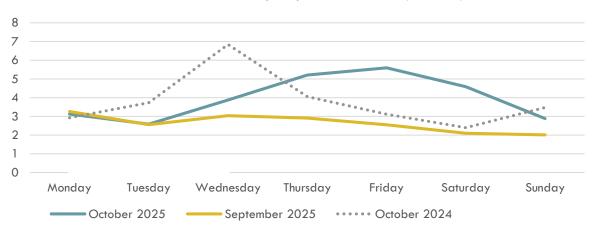

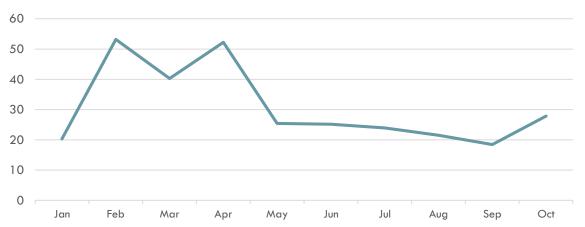




## Natural Gas Market By Days Trade Volume (mio.Sm<sup>3</sup>)



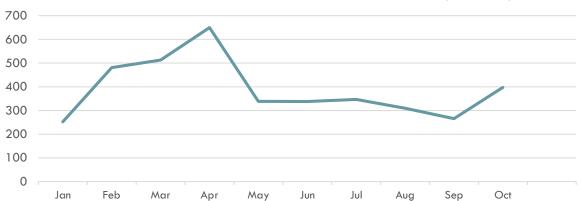
## Natural Gas Market Annual Trade Volume for 2025 (mio.Sm³)



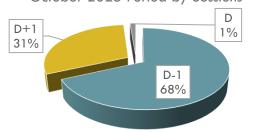

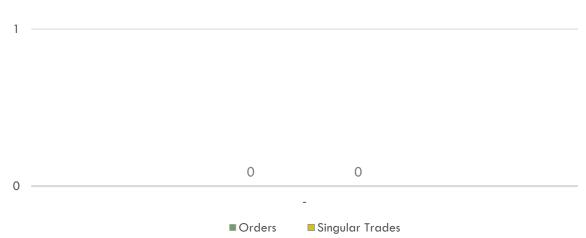

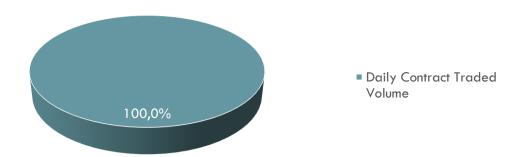

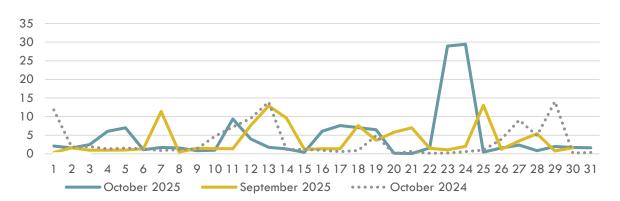

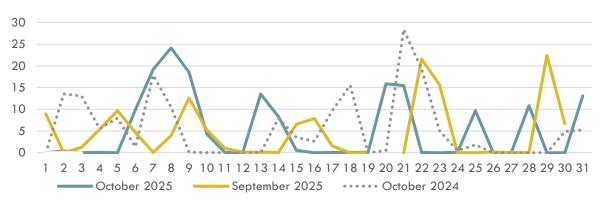

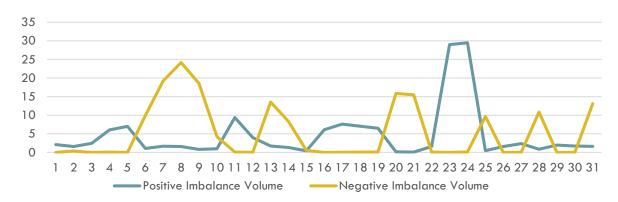
### Natural Gas Market Positive Imbalance Volume (mio.Sm3)

### October 2025 Period Negative and Positive Imbalance Volume (mio.Sm³)

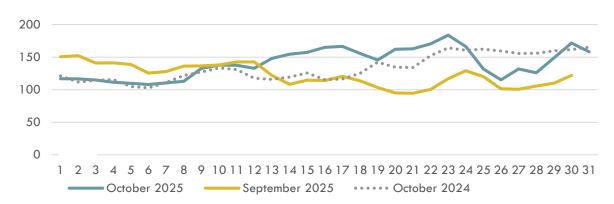

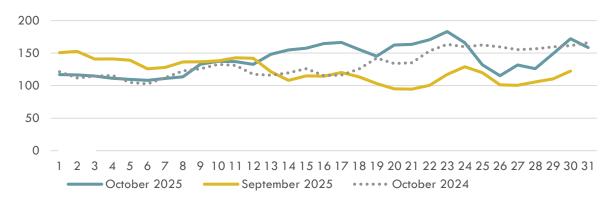

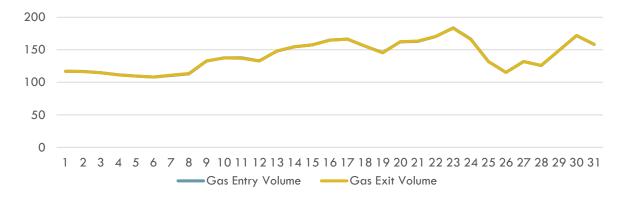




### Natural Gas Market Gas Exit Volume (mio.Sm3)
